


POWER EXCHANGE

- According to cooperation agreement NPS provides price calculation services to BALPOOL.
- In the year 2011, 68 percent of electricity, consumed in Lithuania, was bought in PEX.
- There are 32 Power Exchange members.
- Law on Electricity is a major obstacle to agree exact day for NPS office/activities in Lithuania. Baltpool/Litgrid and NPS work together to finalize the project asap.




RETAIL MARKET SHARE IN LITHUANIA


TENDENCIES OF TRADING IN LITHUANIAN POWER EXCHANGE

- 1) Price in 2011 was lower than in 2010.
- 2) Lower activity of local suppliers.
- 3) Stronger correlation with Estonian market.
- 4) Market gets highly related to international trade (10% of the turnover is exported, 93 percent imported electricity).
- 5) Electricity from Kaliningrad lowered the load for the lines of Lithuania.




8 Baltic sea countries and European Comission agreed on plan to integrate Baltic states with the rest of EU energy market by 2015.


- Year 2016 there should be finished interconnection Lithuania-Sweden (700 MWh) and Lithuania-Poland (500/1000 MWh).
