- Changes in legislation
- Investment descision(s) made



Renewables (1)

Law on Renewable Energy Resources (in force 05/2011):

- small generators (installed capacity up to 30 kW) will get tariff for 12 years
- generators with installed capacity over 30 kW must participate in auction, if they win, they get tariff for 12 years, if not – they must go to power market exchange
- auction zones (to be approved by the Government)
- transparient rules for usage of networks
- no double support (EU or national funds vs. tariffs)



Renewables (2)

Secondary legislation approved by the Regulator:

- Methodology for calculation of the prices for the renewable energy resouces and related rules, implementing the Law on Renewable Energy Resources
- Methodology for calculation of the market price
- Amendments of the Methodology for calculation of the prices for the public service obligations (differentiation)
- Amendments of the Methodology for calculation of connection fees (fees in average reduced 10-25% since 01/09/2011 for 4 customer groups)
- Amendments of the Information submission rules
- etc.

To be approved:

- Fixed tariffs
- Rules on renewables incentives (to be approved by the Government)

Proposed fixed renewable energy tariffs

- 1. Solar (integrated) 1,83 LTLc/kWh (0,53 EURc/kWh)
- 2. Solar (non-integrated) -1,47 (0,43)
- 3. Wind 0,36 (0,10)
- 4. Hydro (building the dam) 0,36 (0,10)
- 5. Hydro (non-building the dam) 0,26 (0,075)
- 6. Biomass 0,66 (0,19)
- 7. Biogas (electricity) 0,64 (0,185)
- 8. Biogas (gas from organic waste) 0,42 (0,12)



Law on Energy

- Main amendments (mainly EU 3rd package) of the Law on Energy in force from 01/2012
 - revised functions of the State institutions
 - requirements for the National Energy Strategy
 - more precise provisions regarding:
 - licensing, issuing of permits and certificates
 - international cooperation
 - complaints
 - fines
 - Strengthened NRA independance
- Secondary legistlation to be adopted/amended



Draft Law on Electricity

- Proposed main amendments of the Law on Electricity are still in the Parliament:
 - 3rd Energy package provisions
 - Supplier of Last Resort (auction)
 - PEX implementation on the regional basis (Nord Pool Spot AS)
 - Pricing regulation provisions




NORDBALT INVESTMENTS

- In July 2011 investments of the interconnection NordBalt for period 2010-2016 were approved
- the precise sums about 25 thous EUR, included in the transmission tariff annually
- Total sum is 139 thous EUR or about 70% of the project
