## **Conclusions of the MIBEL's Council of Regulators meeting (4<sup>th</sup> Jul 2012)**

- ▶ Inputs for a coordinated mechanism:
  - Agreement reached by MIBEL's Council of Regulators in 2010
  - Progress at European level (LTR TF)
  - TSOs Integration Framework in CASC

## **Conclusions of the MIBEL's Technical Council meeting (19<sup>th</sup> Sept 2012)**

- ▶ NRAs agreed TSOs must request ERSE, CNE and Ministries, if applicable, a letter of comfort regarding the extension of CASC to IPE auctions (a joint proposal)
  - TSO's letter must include an updated planning and description of the project and costs associated (taking into account IFE project updated planning)
  - The updated joint proposal would be in place to provide for the auctions aimed at 2<sup>nd</sup> half of 2013 products through CASC platform
- ▶ CNE and ERSE communicated this request respectively to REE and REN on 28<sup>th</sup> September 2012

## **Next Steps**

- ▶ October: TSOs will send a request for comfort to ERSE, CNE and Ministries, if applicable
